

NORTH SEA



- Fishing, oil and gas, offshore wind, shipping, aggregate extraction, conservation
- Drivers for transboundary cooperation – plans for interconnectors / energy grid, cumulative effects on Natura 2000 sites and species

- MSP authority: Minister for Housing, Planning, Community and Local Government







- National MSP study 2011 (POEM)



PORTUGAL: Plano de Ordenamento do Espaco Maritime


- Mapping maritime activities (existing and potential)
- Planning maritime activities and promoting land-sea integration
- Ensuring the sustainable use of resources and the efficient use of maritime space
- Promoting the economic, environmental and social role of the sea
- Produced maps including zoning uses and activities, management guidelines and a monitoring programme

UNITED KINGDOM

- 'Marine planning' covering the UK Marine Area
 - inshore (internal and territorial waters)
 - offshore (EEZ and continental shelf)
- UK Government (Defra) leads on strategic policy and international cooperation
- Separate marine planning authorities for England, Scotland, Wales & Northern Ireland
- Marine competencies vary according to devolution settlements
- Marine Policy Statement 2011: highlevel UK-wide policy



UK: Northern Ireland & Wales



UK: Scotland

- Marine (Scotland) Act 2010 included provisions for MSP
- National Marine Plan published March 2015 (policy document)
- Regional Marine Planning for territorial waters to be delivered by 11 Marine Planning Partnerships by 2021
- Shetland most advanced due to pilot MSP process
- Scottish Government now focusing on Review of National Marine Plan (due early 2018)
- Key practices: Scotland's Marine Atlas, renewable energy activities, National Marine Plan Interactive Online Tool

UK: England

- Marine and Coastal Access Act (2009)
- Regional approach to planning, all led by the Marine Management Organisation (MMO)
- Numerous strategic practices to support planning in England:
 - Strategic Scoping Report
 - Socioeconomic study
 - Guidance for stakeholders and local authorities
 - Online Portal: Marine Information System





BELGIUM

- First national MSP for Belgian North Sea in 2014, now implementing the plan
- Early MSP was non-statutory with MSP law set out in 2012
- Currently reviewing fisheries regulations (by March 2017)
- Co-location of wind / aquaculture being explored by Ghent University
- Key project in informing MSP: GAUFRE and C-Scope







- MSP coordinated by the Dutch Ministry of Infrastructure and Environment, but is inter-agency in approach
- National Water Plan policy framework guides MSP for the North Sea (2016 – 2021)
- Staged review, planned in 2018 and 2020
- Key project: MASPNOSE, MSP Challenge 2050 game, NorthSEE (current)








ATLANTIC PROJECTS

- Transboundary Planning in the European Atlantic (TPEA)
- Explored an approach to cross-border MSP
- Government bodies, research centres and data agencies (Ireland, Portugal, Spain, UK)
- Focused on stakeholder engagement, governance and legal frameworks, data management

NORTH SEA Regional Activities

- Emerging partnerships and cross-border working e.g. North Sea Declaration on energy cooperation (including Working Group on MSP)
- North Sea Grid Initiative to develop interconnectors between bordering Member States
- Role of the North Sea Commission in promoting common interests at a political level, including developing the North Sea Strategy 2020
